# **POLITICS**

If you are one who contacts congressional representatives about measures in congress, here are a couple to mention: HR822 is the National Concealed Carry Reciprocity Act of 2011 (now 2012). It has passed the House by a 272 to 154 vote, and it is now stuck in the Senate. It needs to be passed. The other is HR3594. It would block any taxpayer funding to the UN if they take any action to infringe or abridge any rights of US citizens are that are constitutionally protected. State of Arizona tired of the Federal stonewalling in the "Fast and Furious" investigation, has started their own probe to see if any state laws have been broken and can be brought to bear.
